Pursuant to Bankruptcy Rule 3002(c), the Claims Bar Dates have passed which are the deadlines for most creditors to file a claim in your case. However, primary residence mortgage holders have additional time to supplement their claim and/or the plan may provide additional time for creditors to amend their claim, such as a creditor receiving surrendered collateral. If a creditor is treated as secured under the plan and has not filed a claim, then the debtor may consider filing a claim on its behalf to ensure distribution or accumulation of funds. Funds will not be distributed to creditors without a claim filed. Typical issues discovered in this report are:

1. Creditor submitting duplicate claims.
2. Creditor claiming too much money is owed
3. Mortgage or car creditor not filing a claim that should have been filed
4. Aggregate claims higher than anticipated at the time of filing

To monitor additional/supplemental/amended filed claims hereafter, the debtor(s) and their counsel may want to periodically review the Claims Register in ECF or the semi-annual Trustee's Report of Receipts and Disbursements mailed to you. It is the responsibility of the debtor(s) and their counsel to take appropriate legal action, if necessary.
